**Carol Barnes, ARM**, is Insurance Manager with the Office of Risk Management at Baylor College of Medicine in Houston, Texas. She has worked in the insurance industry for over thirty years in such diverse areas as the energy sector, restaurant and nightclub management, and Texas Non-subscriber injured employee claims. Ms. Barnes has been with BCM since 1995.

At BCM Ms. Barnes handles all claims for damages (except medical liability and workers' compensation), the renewal of the college's property & casualty insurance policies, contract review for coverage and proof of insurance, and various other responsibilities. Ms. Barnes also functions as the department SAP (accounting/budget) liaison, computer liaison, and web master. Carol received the Associate in Risk Management designation in 1987 and a Bachelor of Arts in Computer Science from the University of St. Thomas in Houston in 1991.

She has held various board positions for the Houston Chapter of the Risk & Insurance Management Society including president (2000), chapter liaison to the national office, and web master. She was also a member of the RIMS-National Mentoring Team working with 3 chapter boards. Ms. Barnes is a member of the Greater Houston Society for Healthcare Risk Managers and the National Notary Association.

Carol has been chosen by the **2006 Spencer Educational Foundation to be a Risk Manager in Residence at Temple University.** This prestigious position involves visiting a university with a risk management program and meeting students as well as viewing some classes.

## Insurers Announce Earnings

HAMILTON, Bermuda-A tame hurricane season helped Arch Capital Group Ltd. post profits of \$453.3 million for the first nine months of 2006, nearly triple the year-earlier period. The Hamilton, Bermuda-based insurer and reinsurer posted net income of \$185.8 million for the quarter vs. a net loss-stemming from heavy 2005 hurricane activityof \$86.3 million in the priorvear period. The third quarter of 2006 "did not include any material catastrophic activity," Arch noted in a statement. Arch reported higher gross written premiums for the nine-month period, increasing to \$3.41 billion compared with \$2.97 billion last year. The company's combined ratio was 86.3% for first nine months of this year, an improvement from 98.9% for the first nine months of 2005.

NEW YORK —The Hartford Financial Services Group Inc., the fourth-largest U.S. insurer by assets, said that earnings rose a better-than-expected 41% in the third quarter, helped by the absence of any major catastrophes such as hurricanes. The company also raised its forecast for operating earnings for 2006.

The Hartford, Conn.-based carrier said earnings were \$758 million, or \$2.39 a share, up from \$539 million, or \$1.76 a share, in the year-earlier quarter.
