Mr. Cameron Arimoto is the Head of Enterprise Risk Management (ERM) for AmerisourceBergen, a leading global healthcare company, with a foundation in pharmaceutical distribution and solutions for manufacturers, pharmacies, and providers. With over 42,000 employees operating in over 50 countries, AmerisourceBergen provides wholesale and specialty distribution, manufacturer and commercialization solutions, and consulting services across human and animal healthcare networks. AmerisourceBergen is ranked #8 on the Fortune 500 with more than \$200 billion in annual revenue. During the COVID-19 pandemic, AmerisourceBergen partnered with various government agencies and supply chain partners to support the collective distribution of more than 75 million vaccines across 30-plus countries. In his role as head of the Office of ERM, Cameron facilitates operational and enterprise risk management processes to collaboratively identify, assess, mitigate, and monitor risks at all levels of the organization, to promote the continued growth, success, and sustainability of AmerisourceBergen.

Previously, Cameron worked across public and private-sector industries in risk management and management consulting roles.
