### MALPRACTICE MEANS MONEY

Limiting medical malpractice lawsuits has continually been a hot debate in healthcare cost containment, but the issue has recently been thrown back into the middle because budget umpires from Congress have said that this technique would cause doctors to order fewer tests and save taxpayers billions more than originally The Congressional thought. Budget Office estimates that government healthcare programs could save \$41 billion over ten vears if there were limits pain and suffering and similar curbs were enacted.

CBO Director Douglas Elmendorf acknowledged that doctors practice defensive medicine in order to guard themselves from a malpractice suit. An example of patient with back pain rather than a \$250 X-ray to cover themselves in the unlikely chance they will be accused of having not found a cancerous tumor.

"The more federal health care programs spend on unnecessary tests, the less money is available for necessary patient care," said Sen. Charles Grassley of Iowa, also noting that \$41 billion is "not chump change."

However, little is being done about the issue. This has been partially attributed to the trial lawyers who file malpractice lawsuits being strong supporters of the Democratic party and also to patient advocates who worry that these limits will prevent fair compensation to those patients who suffer the most harm because of a doctor's negligence.
