ARRAIGNMENTS: LEGAL WOES CONTINUE FOR INSURANCE GIANT

As if AIG's name hadn't been drug through the mud enough over the past year, the world's largest insurer took another hit last Tuesday, as former Vice President of Reinsurance Christian M. Milton was sentenced to four years in prison for his involvement in a fraudulent scheme involving AIG and General Re. Corporation. Former Gen Re CEO Ronald E. Ferguson was sentenced to

two years in prison last month for his involvement in the dealings. Both men received fines of \$200,000 in addition to the jail sentences. Milton was the second of five convicted former executives to be sentenced. The defendants were found guilty of conspiracy, securities fraud, and making

false statements to the U.S. Securities and Exchange Commission. Elizabeth Monrad, former financial officer for Gen Re, will be sentenced on Feb. 12; Christopher Garand, former SVP in charge of US finite underwriting, will be sentenced on March 4.

In November, Judge Christopher Droney of the U.S. District Court in Connecticut ruled that shareholders had lost more

than \$500 Million in a phony finite reinsurance deal between AIG and Gen Re that was designed to help AIG manipulate its financial statements.

In the sentencing of Milton, Judge Droney varied rather significantly from the federal sentencing guidelines, which called for life in prison. Judge Droney claims that Milton knew that this "was

not a bona fide transaction, but rather one designed to cook the books of AIG," but maintains that Milton was not motivated by personal gain. Also at play in the reduced sentencing were over 70 letters from former clients and colleagues, presented by the defense, that described Milton as an

"extraordinary and compassionate individual." Defense attorney Fred Hafetz also asked Judge Droney to consider the impact of the sentencing on Milton's family, who faced a "likelihood of deportation," if Milton were in fact incarcerated. Milton was ordered to report to prison on March 25.
