Tom is widely published and is the author of *Value and Capital Management: A Handbook for the Finance and Risk Functions of Financial Institutions* published in the Wiley Finance Series. His book has been translated into Chinese, Korean and Japanese.

Tom is an Honorary Professor of Applied Risk in Insurance at the Ludwig-Maximilians-Universität in Munich, Germany, and Board Member of the American Risk Insurance Association. Tom earned his BSc in Business Administration with honors from the University of California at Berkeley and his PhD in Economics from Stanford University. Tom is a dual American/Swiss citizen.
