The American Institute of Chartered Property Casualty Underwriters (AICPCU) grants numerous designations to both professionals and students who take and pass a series of exams provided by the institute. Taking any of the CPCU or related exams is strongly encouraged for Risk Management majors focusing on Property & Liability.

The Certified Employee Benefits Specialist designation is granted jointly by the International Foundation of Employee Benefit Plans and the Wharton School of the University of Pennsylvania to individuals who complete eight college level courses and examinations in the areas of design and operation of employee benefit plans and who pledge to a code of ethical standards and continuing education.
