Jen Ughetta is the Head of Talent Management & Development for Munich Re where she has responsibility for talent management, performance management, succession planning and learning & development across the US operations. Jen was also responsible for establishing an employee resource group called the Women's Network and sits as co-chair on the corporate steering committee. Additionally, Jen plays a key role on global expert teams focused on talent management and development topics.

Over the past 15 years she has held a variety of positions in Munich Re HR, including designing and implementing an HR Service Center, leading the Staffing & Global Mobility function and, most recently, implementing an integrated talent, performance and learning framework and technology solution across five companies that span the Munich Re US operations.

In 2008, Jen was recognized as one of Training Magazine's "Top Young Trainers" for her leadership skills, strategic thinking and commitment to the industry. She continues to demonstrate a strong commitment to growing and developing talent at all levels throughout the Munich Re organization and beyond.

Jen holds a Bachelor's degree from the University of North Carolina at Wilmington, and a Master's degree in Human Resource Management from Rutgers University. She also holds the Senior Professional in Human Resources (SPHR) designation from the Society for Human Resource Management (SHRM).
