Bonnita 'Bonnie' Boone

Ms. Boone is a Senior Vice President of Alliant Insurance Services, in Chicago and New York. She has 34 years in the insurance industry as a broker and underwriter. She focuses on program design and structure, manuscript policy wording, captive formation, captive reinsurance and rate/premium analysis for the healthcare industry. She has expertise in Medical Professional liability for Long Term Care, LTAC's, Managed Care Organizations, Hospitals/Integrated Delivery Systems, Physicians and University Medical Centers. She is also an expert in understanding the other extended coverages for healthcare systems: HMO reinsurance, Cyber Liablity, D&O, and Environmental.

She was elected in 2008 and 2009 as a "Power Broker for Healthcare" by Risk and Insurance Magazine and honored by Business Insurance as, "A Women to Watch" in 2008. She is presently the broker on some of the largest Integrated Delivery Systems in the country such as SSM Healthcare, the first Malcolm Baldrige winner in Healthcare in St. Louis, Mo.

Her previous experience includes a national position for 10 years, with Willis, the third largest insurance broker in the world. Her focus as a national resource was working with 280 retail offices on a global basis to solicit/produce business, market, and set strategy for the healthcare industry. She chaired product line/industry segments for Long-Term Care, Managed Care, and HPL, (Integrated Delivery Systems) and miscellaneous healthcare. Her experience included placing reinsurance for some the largest captive programs in the country (Humana Inc. HCA/Columbia, etc).

Additional previous experience includes managing an underwriting staff and a book of business for Continental Insurance Company with a premium volume of \$103 million. Establishing market direction, reinsurance treaties, developing rates, underwriting guidelines and corporate strategies were a part of her duties. Prior to the Continental Ms. Boone served as a Vice President for Marsh of New York where she managed a team of professional brokers and book of business, for some of the largest healthcare facilities in the New York area. Ms. Boone has underwritten, and brokered 5 of the top 10 Managed Care Organizations in the country.

Bonnie is an accomplished lecturer and author having spoken on many healthcare topics at numerous industry conventions. She has taught numerous classes on professional liability with special emphasis on medical malpractice at conferences such as: RIMS (numerous topics including managed care in 1995 and 2003), Crittenden Healthcare Conference (Managed Care and market place in 2002), ASHRM (Enterprise Risk Management in 2005), PLUS conference (Medicaid and Medicare Fraud and Abuse), Blue Cross Blue Shield National Risk and Insurance Conference (key note speaker in 1997), and IIR Institute of International Research (capitation). She has chaired a seminar on Professional Liability Today and the Integrated Healthcare Delivery System in 1999 for IIR. She was recently a speaker for the PLUS conference on Medical Professional liability for discussing the state of market March 24, 2009. She has written various articles for numerous periodicals with emphasis on healthcare. Her articles available on the International Risk Management Institute website and are among the highest viewed. She currently sets on the board of ASHRM New York working with the Educational Committee and the Sponsorship Committee. She also participates on the Chicago CHRMS educational committee, where she received in March of 2011 the Peggy Cwik Life Time Achievement award. She recently spoke at the 2011 RIMS conference in Vancouver BC and at the IMAC conference in the Caymans December of 2011. In December of 2011 and 2012 she was a speaker at the Business Insurance Women to Watch workshops.

Bonnie is a licensed in 40 states and holds a Bachelor of Arts degree in Communications from Xavier University and is currently working on her MBA.
