AS Workshop: How to Prepare for the Actuarial Student Career Reception

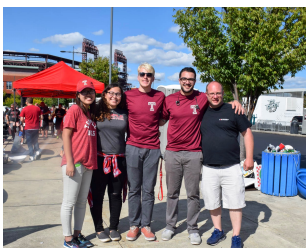

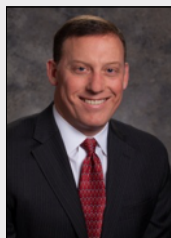
